Pursuant to the aforesaid MCA Circular(s) and pursuant to the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013 and the relevant Rules made thereunder, the Company will send this Postal Ballot Notice by email to all its shareholders, who have registered their email addresses with the Company or depository/depository participants and the communication of assent/dissent by the members will only take place through remote e-voting process. This Postal Ballot is accordingly being initiated in compliance with the above said Circulars.

In compliance with the requirements of the MCA Circular(s), the hard copy of this Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope will not be sent

to the shareholders and hence, the shareholders are requested to communicate their assent or dissent through remote e-voting process only.

The Board of Directors of the Company, vide their resolution passed on May 05, 2023, has appointed M.D.Selvaraj, FCS, Managing Partner of M/s. MDS & Associates LLP, Company Secretaries, "Surya Enclave", No.37, Mayflower Avenue, Sowripalayam Road, Coimbatore - 641028 as the Scrutinizer for conducting the Postal Ballot voting through electronic means in a fair and transparent manner and for ascertaining the requisite majority in compliance with Rule 22(5) & (6) of the Companies (Management and Administration) Rules, 2014.

Pursuant to Regulation 44 of the Listing Regulations and pursuant to the provisions of Sections 108 and 110 of the Companies Act, 2013 read with the relevant Rules and the MCA Circular(s), the Company has provided electronic voting ("e-voting") facility only.

STATEMENT SETTING OUT THE MATERIAL FACTS PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013:

The following statements sets out the material facts relating to the special business mentioned under Item No.1 in the accompanying Postal Ballot Notice dated 5th May, 2023 and shall be taken as forming part of the Notice:

Item No.1

Mr. Baba Chandrasekar Ramakrishnan (holding DIN: 00125662), has been associated with the Company since 2014 as Non-Executive Non-Independent Director. Pursuant to Regulation 17(1A) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), a Non-Executive Director of the Company who has attained the age of 75 years cannot continue to act as a Non-Executive Director in the Company unless the approval of the Members is obtained through a special resolution.

Mr. Baba Chandrasekar Ramakrishnan will attain the age of 75 years on 12th July 2023 and accordingly, pursuant to the said regulation, the approval of the Members by a special resolution is required to be obtained to enable Mr. Baba Chandrasekar Ramakrishnan to continue his directorship in the Company.

Mr. Baba Chandrasekar Ramakrishnan has wide experience in the management and affairs of the Company and is very knowledgeable in administration of Companies. Therefore, the Board of Directors are of the opinion that Mr. Baba Chandrasekar Ramakrishnan has been an integral part of the Board and has provided valuable insights to the Company and his continuation as a Non-Executive Non-Independent Director beyond the age of 75 years will be beneficial to the Company.

Accordingly, the Board of Directors of the Company at their meeting held on 05th May 2023, on the recommendation of the Nomination and Remuneration Committee, approved the continuation of directorship of Mr. Baba Chandrasekar Ramakrishnan, liable to retire by rotation and also proposed to seek the approval of the Members by way of special resolution for the same.
