## Secretarial Compliance Report of M/s. Lambodhara Textiles Limited for the financial year ended 31<sup>st</sup> March 2026

We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Lambodhara Textiles Limited (CIN: L17111TZ1994PLC004929)** (hereinafter referred as 'the listed entity'), having its Registered Office at 3A, B-Block, Pioneer Apartments, 1075-B, Avinashi Road, Coimbatore – 641018.
